


Costs vs. Revenue

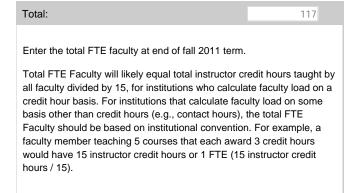



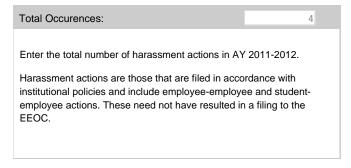
