- 1. Call to Order: Chair, Monica Burnett called the meeting to order at 2:03 p.m.
- 2. Approval of Minutes: Minutes of the April 12, 2013 meeting was reviewed. Added statement to page 4-Helen Nishimoto nominated Tony Kent for College Council Chair. Motion made by Tony Kent to approve the minutes with the change. Helen Nishimoto seconded.
- 3. Chancellor's Update- Chancellor Noreen Yamane is on Oahu. No update

Motion made by Marcy Martinez to accept the Assessment Committee to be a permanent standing committee of the College Council. Seconded by Marilyn Bader.

Discussion-

Note that the Responsible Area is the College Council.

Helen Nishimoto noticed that the application has a mistake on the composition of members. It is missing the Academic Senate Chair. The charge of the Assessment Committee is that the Academic Senate Chair is a member of the Assessment Committee. It was left out in error on the application.

Should the application be taken back to the constituents to get feedback and return to the council? Does the application need to be amended?

Motion made by Helen Nishimoto for a proposal to amend the application to add the Academic Senate Chair to the composition and still consider the motion to make the Assessment Committee to be a permanent standing committee of the College Council. Seconded by Jason Cifra.

No discussion to the amendment. All in favor- Unanimous.

Continued discussion on the Assessment Committee-

- The Assessment Committee is the main group that can explain the results of the assessment and how it is aligned to our ILOs. Information can be given to the College Council so they can discuss and examine the ILOs.
- It was emphasized that the Assessment Committee assists both programs and units. Not all the units are with Academic Affairs. Assessment for instruction program has a June 1 deadline. Units will receive separate instructions and deadline.
- Assessment Committee comes up with the methodology for programs and units. The programs and units are responsible for their assessment. College Council is responsible for ILOs.
- Propose that the Assessment Coordinator write a special report to the College Council that shows how program and unit outcomes align with ILOs.

Motion made by Marcy Martinez to amend her initial motion to make the Assessment Committee a permanent standing committee provided we add in the application– "provide a summary report that shows how program and unit outcomes align with ILOs", after the function of the E 'Imi Pono Development Day activities; and also to add in the Academic Senate Chair in the composition.

Seconded by Helen Nishimoto. No further discussion. All in favor-Unanimous

5. Administrative Affairs Update- VC James Yoshida

a. Handout on Manono Campus Projects Update (Attachment #3)
 List is pretty much the same with some changes on when it will happen.
 Two major projects for certain this summer is: Replace windows in Bldg 381 and Replace Art Kiln

- 6. Student Services Update- VC Jason Cifra
  - a. Major priority for the summer is Orientation and Registration. We will be holding mandatory orientation for incoming students at East and West Hawaii. Facilities are the major barrier. Last year, we had over 1400+ students who participated. There will be lots of students coming to the campus, especially in July. Thank you to all the coordinators, presenters and those helping.

- b. A Summer Math Free Boot Camp will be offered in partnership with Academic Affairs, Waiakea High School, C3T1 Grant, I Ola Haloa, and Halaulani for our students. We will be offering 2 sessions from June 3-7 and 17-21 in Room 133. A flyer is being generated. The first session is priority WHS and the second session is for any student. We are trying to shoot for 20 students per session. We can add more sections if necessary. Thank you to Noe Noe, Kamaka, and Monica for assisting. Gear Up is also scheduling the Summer Bridge program.
- c. Graduation Survey is being completed and will be rolled out as an online survey. Thanks to David, Naveen, Shawn, and the rest of the working group. Naveen is going to automate the survey results, collection and also the notification of students who have not completed the survey. (Attachment #4).
- d. After the legislative session, the University of Hawaii System is going to publish a report regarding sexual violence and DV. Survey was done in 2009-10. The survey population is basically students. These situations are not limited to occurrences on campus. I have attached the HawCC survey. I have also included HawCC measures and activities to promote safety and awareness on campus. (Attachment #5 and Attachment #6)
- e. As we close out the semester, we would like to ask for your kokua to spread the word that grades have to be in by May 13, 2013. We have made great strides to close our semester on time. This is critical as we use Records data to review and identify student groups to target.
- f. When we open in the Fall, we will have 4 new people thanks to the C3T2 grant. The purpose of the grant is primarily for college completion, but also now for career placement and internship placement. These positions will be imbedded in Student Affairs to support graduation and career placement goals. We are hiring:
  - 1. Transcript Evaluator (To support transcript evaluation from other institution, and also support how we institutionalize. How we provide credit to students who may have prior learning experience, work experience and other certification that is not tied into a formal college credit work course.)
  - 2. Data Technologist (To help us track the students who are participating in this grant, and will also help with the Web and reporting.)
  - 3. Internship Coordinator (To help identify opportunities for our students in the community, whether it is paid internship, for experience or for stipend.)
  - 4. Career Counselor (To support career awareness and guidance.)
- g. Next year, I will present data to the council so that we are all aware of our campus and students' performance. We will track their progression from semester to semester and then year to year. We are working with Joni, Grace, David and Dorinna. Trends are showing that we are bringing in enough new students but are losing continuing students.
- h. Lastly, Mahalo Nui to everyone who make student success a priority. Even with our challenges and limitations, it's been a pleasure seeing the collaboration and dialogue happening across campus.
- 7. West Hawai'i Update- Interim Director Beth Sanders

- a. We participated in a West Hawaii Earth Day celebration at Kealakehe High School to increase awareness of higher education opportunities in the community, to get students to stay in school and graduate to attend college. We had over 80 youth, ranging from pre-school to seniors in high school that signed a promise to stay in school and graduate and go to college.
- b. We were featured along with Hawaii Community College, Construction Academy at Honokaa High School in a newspaper article on April 28, Star -Advertiser "New Initiatives Aim to Combat *Brain Drain*"
- c. Earlier this week we successfully moved the pohaku that was still part of the road planning on the Palamanui campus site. It was moved to protect it from being damage during construction. A temporary location was built until such time it's ready to move back to the Palamanui campus.
- d. The Palamanui Groundbreaking Ceremony was set yesterday by President Greenwood May 28, at 12 noon.
- e. Will be recruiting shortly for a Clerk Typist II, digital service and main receptionist. The person will be located where Lori Cecil has been. Lori's last day is June 28, 2013.
- f. Looking forward to graduation is on Saturday, May 11 at the Hilton Waikoloa. We hope to see many of you there. We have almost as many students this year as we did last year. We anticipate every student to be at the actual ceremony. We probably have about 120-130 graduates from the West Hawaii area this year.
- g. Mahalo to everybody for all your support. This will be my last meeting as Interim Director. I will be moving back to Faculty. I appreciate all the ways that we increased the awareness of what we do at West Hawaii over the last few years.
- 8. OCET Update- Interim Director Debbie Shigehara
  - a. Thank you to Tony Kent for giving the OCET report for all these months.
  - b. Update on the RDP sustainability grant which ends at the end of this month.
    -EIMT students changed all the lights in Bldg 388 to LED lights.
    -We will purchase (3) three water fountains, so you can fill your water bottles, to be located at Bldgs 387, 388 and 379A.
  - c. The Distant Education grant ends this month. High definition equipment & cable should be coming soon and will be installed this summer.
  - d. There will be Pre-Bid awards for contractors to work on the Motorcylce Training in the back. On May 13, at 9 a.m. we will have some contractors on campus to pick up bids. The project will be completed by end of summer.
  - e. We are working with Honolulu Community College for a one week welding program this summer to be held at the MWIM building. People from the islands and the continental United States will be coming.
  - f. OCET will be working on a grant to upgrade skills for people in the Harriet Union. The only Harriet property is Waikoloa Marriott. The grant will offer training to employees who want to

upgrade into a higher position, such as an employee who wants to move from housekeeping to accounting.

g. As part of the C3T1 grant, we will have 2 positions that will be out in the community for testing and recruiting for us. They will both be working under WDD, one position here for Hilo and the other position will be located at NHERC for Kona. We hope to get casual hires position set up in a couple of weeks. C3T2 is also known as Rural Hawaii Project.

### 9. Unfinished Business

a. Re-election of 2013-2014 Council Chair

Chancellor Yamane set out an e-mail notice on April 29<sup>th</sup> to the Council Members reminding us the new Chair needs to align with the Council Charter on membership. Thank you to Tony Kent who was willing to serve as the next Council Chair, but is ineligible per the Charter membership requirements.

Chair Burnett called for nominations for the 2013-2014 College Council Chair.

Wendy Medeiros nominated Manai Kalua as next College Council Chair. Marcy Martinez seconded the motion. Chair Monica Burnett said Manai is willing to serve as chair, he is a faculty member. No other nominations. No discussion. All in favor- Unanimous

- 10. New Business:
  - a. "No Pets on Campus" Policy-Jim Yoshida VC James Yoshida proposed to the College Council to recommend or not recommend that we have a policy about pets on campus.

Prior to 2006 the campus was under the control of UHH and they had a policy of no pets. When we assumed the responsibility for the campus in 2006 nothing was put into writing, but the policy that was in place previously was enforced.

We do not want to make the policy complicated. Right now in the whole system (10 campuses), UH Manoa and UHH have a policy about pets and feral animals. Only Maui College has a policy which is very plain and simple -no pets except service animals are allowed on campus. This is primarily to establish in writing what was unwritten previously. People have asked if there are any problems with pets on campus. It's not really a problem with faculty, staff and students but more of an issue with the public that come on campus and cleaning after their pets. It would be good to have a policy, if/when we need to tell people not to bring their pets on campus.

Discussion-

Currently there is no such policy in the Policies and Procedures Manual. The Kukui News, of March 31, 2011 had printed–Pets are not allowed on campus, only certified and guide aide pets are allowed on campus. This was based on UHH policy.

The Information Center standard reply regarding pets is that because UHH and Hawaii CC share campuses we also honor UHH's pet policy.

A service animal is defined as a dog or a miniature horse. People don't realize that the law has changed such that a service animal is not specifically identified with a card.

Motion made by Marcy Martinez to recommend to the Chancellor that we adopt a No Pet Policy on our campus, except service animals. Seconded by Guy Kimura All in favor- Unanimous

- ATE Construction is looking into submitting an Authorization to Plan for FENG (Facilities Engineering).

- 3. General Education (GE)
  - Lou Zitnik and Ellen Okuma will be co-chairing the Ad Hoc General Education Committee.
  - Those courses identified as the core general education courses will be accepted first and should review and update its Course Outlines to be reading to apply for designation.
- 4. Summer Courses
  - Summer enrollment has been slow. An ad will be in May 12<sup>th</sup>'s Hawaii Tribune Herald to publicize summer school.
  - In-class tutoring is being requested for remedial/developmental courses.
- 5. ITSO
  - The TCC Online Conference had over 1000 attendees (a major increase since last year's conference). At least 29 Hawaii CC faculty and staff were registered. One of the was called "Giving Credit Where and When It Is Due: Adventures in Digital Credentials and Badges," presented by Jonathan Finkelstein, President and Founder of LearningTimes. This was a particularly interesting session that suggested a way to manage credits and credentials in an increasingly complex computer driven educational environment.
  - There will be 7 participants in this year's OCDP cohort: Jessica Lerma, East Hawai`i, lecturer, PHIL 110, Spring 2014 Charlene Merritt, East Hawai`i, lecturer, SUBS 280, Fall 2013 Violet Murakami, East Hawai`i, faculty, ART 112, Spring 2014 Gwynne Pacheco, West Hawai`i, lecturer, PSY 100, Fall 2013 Kimberly Pierce, East Hawai`i, lecturer, SOC 251, Spring 2014 Beth Sanders, West Hawai`i, faculty, ACC 155, Fall 2013 Jacqueline Stradtmann-Carvalho, East Hawai`i, faculty, MATH 26, Spring 2014 The program will officially begin on May 20 with the start of the six week online course.

Participants have been notified of their selection and have confirmed their participation.

• ITSO's annual survey closed on April 17. The survey went out to all faculty, staff & lecturers, but we requested only instructional faculty (and lecturers) respond (n=188\*). A total of 60 (32%) faculty responded. Analysis of results are still being done but at first glance, the feedback is positive in terms of service, knowledge, and impact.

\*188 includes all faculty and lecturers listed in the Class Availability listing as of April 24, 2013 (not including IEP or Construction Academy instructors)

- 7. Computer Services
  - has been receiving, responding to, and completing a number of work requests.
  - has been preparing for the purchase, storage, and eventual installation and placement of 162 new computer systems.
  - is preparing for the upgrade of 450 Windows XP Professional systems which will need to be migrated to Windows 7 Professional this summer.
  - is beginning the process for the replacement of the wireless network on the UHH campus.
  - There was a DMA software licensing issues where the software had been registered to a former temporary APT staff. This is creating some issues with the vendors. This is a reminder that all software should be registered through Computer Services.
- 8. The Learning Center / Hale Kea
  - HKATC will be closed from May 13-17 for waxing and cleaning.
  - TLC will be closed from May 20-24 pending Auxiliary Services approval.

- The elevators in the Library will start their renovation project on May 15 to Aug 30, 2013.
- A security camera will be installed outside the exterior of TLC in Fall 2014 semester.
- HKATC is looking into installing surveillance cameras for security purposes to be installed in testing room 109 of the HKATC building.

    - review Action Plans and Action Plans results
  - support E 'Imi Pono Development Day activities and develop other college assessment events
- Perform duties and responsibilities (in relationship to college assessment and within the Assessment Committee):
  - The Institutional Assessment Coordinator: notifies programs and units of assessment deadlines; keeps accurate assessment records and publishes results
  - Administration: set and enforce deadlines
  - Working Assessment Group: support and facilitate the campus assessment efforts through working groups and training


