Assessment Committee Activities

- The Assessment Committee has met twice so far in Spring 2016, with additional meetings scheduled for April and May¹.
- Members have provided continued support for the College's search for a commercial Assessment Management System (AMS), including technical and task-group support to confirm references for the proposed vendor, Campus Labs.
- Members continue our work on proposed revisions and updating to the HawCC Assessment Policy #5.202 and the development of a specific Program/Unit Review policy.
- The Committee has experienced some changes in membership during early Spring 2016, including the loss of our OCET representative and a change in our GSSS representative. The current membership list is below:

Assessment Management System (AMS) Vendor search status:

The IAC submitted a Memo to Interim Chancellor Joni Onishi on Feb 6th that included comparisons between the three primary nation-wide vendors under consideration across the UH System, i.e., Campus Labs, Task Stream and Live Text, based on the HawCC Criteria

List developed by the IAC and approved by the Assessment Committee. As well, this document detailed rationale for the IAC's recommendation that the College purchase **Campus Labs' OUTCOMES** product as our new web-based AMS.

On March 30th, Chancellor Onishi informed the IAC that the College has agreed with this recommendation and is in the process of pursuing funding for the required three-year contract, with implementation expected in mid-Fall 2016 and full roll-out to the campuses in Spring 2017.

- The CERC will be meeting in April to evaluate the Comprehensive Reviews
- Status Update to March 31, 2016
 - o 29 of 32 required Program Annual Reviews have been posted, 91%
 - o 9 of 11 required Program Comprehensive Reviews have been posted, 82%
 - o 15 of 29 required Unit Annual Reviews have been posted, 52%
 - o 8 of 11 required Unit Comprehensive Reviews have been posted, 73%
 - In addition, we were able to retrieve and publish missing 2014 Reviews, including 5 Unit Annual Reviews and one Comprehensive Review, all from Student Affairs Units.
