- c. Deployment of ICat (call for suggestions)
 - i. Rachel reported that, according to ACCJC, QFE needs to be focused on student success, and ICat could be the tool we use to gather this information.
 - ii. Survey on January 5th, receive results, World Cafe style discussion on March 2, 2018.
 - iii. Discussion of ways to increase response rate, such as breaking it up and doing parts in division meetings. Another idea is to set up a room with snacks and having a helper to answer questions in the room so people can drop in during Convocation Week.
 - iv. Resh expressed concern that she doesn't have enough time to complete the glossary by Jan. 5th. Rachel suggested having just the first category done by then. Resh agreed.
- d. Budget deficit and guiding questions for units/divisions
 - Rachel reported that, in spring, we need to work on a budget reduction, because we didn't meet performance targets, resulting in a loss of \$600K in funding. This will be a transparent and participatory process, so *feedback from all constituencies is needed*. All cuts needs to align with our goals and mission. In the future, we will only budget performance funds that are actually earned.
