# **Guest Speaker: Chancellor Solemsaas**

Budget 101

Chancellor Solemsaas shared that she values transparency, and she believes that the more people who understand the budget, the better the institution functions.

Revenue is generated through a combination of state funding or local taxation, tuition and student fees, grants and contracts, and local monies.

Unique to Hawaii- funding is allocated by positions, and positions carry over to the next fiscal year.

Public funding is eroding resulting in a shift to tuition increases.

Resource allocation breaks down as follows:

- Filled position (carry over)
- System assessment
- Line items or earmarks
- B expenditures (operating budget)
- Performance funding

Vacant positions may still be filled (must make a case regarding the necessity of the position); sources for new positions are as follows:

- Vacant position reallocation
- Additional tuition revenues (noted as temporary funding)
- New legislative requests

Strategies for balancing the budget include increased revenue and decreased expenditures.

Tuition revenue is anticipated to decrease.
