- **a.** 2019-2020 Budget
 - Claudia requested that administration share the 2019-2020 budget, but she did not receive a copy.
 - Chancellor Solemsaas did, however, send an email to HawCC faculty and staff regarding the 2019-2020 budget.
 - A system change regarding tuition payment will be implemented this fall. The "purge" date (when students are dropped due to nonpayment) previously was in August, but students could re-register the following day after being dropped. Beginning this fall, students who do not pay for their tuition or set-up a payment plan and/or do not have a financial aid award in place by September 6, 2019, will be dropped from their fall courses. This means that students cannot simply go online and re-register as they could before. Kenoa is waiting for answers regarding whether students awaiting financial aid awards that have not been awarded by Sept. 6th will be safe or not from being dropped, and she has also asked about an appeal process for students trying to re-register.

Discussion: We should all help make students aware of this significant change to the tuition payment timeline, and we need to share this information with lecturers. Kenoa has a "How to Register" handout that she will share and that can be given to students. Low-income students will be greatly affected by this change. March 1, 2019 was the priority deadline for FAFSA, but students may still submit FAFSA applications for fall 2019.
