The Academic Senate approved Academic Senate Resolution #2019-2: Install Electric Vehicle recharging stations on the Manono and Palamanui campuses, per Hawai'i State Law. Resolution #2019-2

A resolution calling for Hawai'i Community College to install Electric Vehicle recharging stations on the Manono and Pālamanui Campuses per Hawai'i State law.

Whereas, Hawai'i Revised Statutes 291-71 and 291-72 states: All parking facilities that are available for use by the general public and include at least 100 parking spaces must designate at least one parking space specifically for Plug-in Electric Vehicles (PEVs), provided that no parking spaces required by the Americans with Disabilities Act Accessibility Guidelines are reduced or displaced. Spaces must be clearly marked and equipped with electric vehicle supply equipment (EVSE). An owner of multiple parking lots may designate and install EVSE in fewer parking spaces than required in one or more parking lots, as long as the owner meets the requirement for total number of aggregate spaces for all parking lots, and,

Whereas, Hawai'i Community College does not have recharging stations (EVSEs) on the Manono or Pālamanui Campuses in violation of Hawai'i Revised Statutes 291-71 and 291-72 and,

Whereas, Hawai'i Community College does have over 100 parking spaces on the Manono Campus and Pālamanui Campus is a designated LEED Certified campus and,

Whereas, the use of PEVs are becoming more popular with our students, faculty, and staff,

Be it resolved, that Hawai'i Community College install at least two (2) recharging stations on the Manono Campus and one (1) recharging station on the Pālamanui Campus and.

Be it further resolved, that the recharging stations be free to use up to 2 hours per PEV and,

Be it further resolved, that the recharging stations be installed and operational by the start of the Fall 2019 Semester.
